



## MEDIATION COSTS (annex A)

**Last update: September 1, 2016**

### **Fees in force for mediation cases filed from September 1st 2016.**

The costs include registration fees and mediation fees.

The **fees include VAT (22%) and shall be paid by each party.**

On the purposes of the overall mediation costs, if several subjects have a single-interest issue, they are to be considered as a unique party and they have to explicitly communicate this circumstance to the Secretariat.

### **A – Economic value of the dispute**

The economic value of the issue is declared in the mediation request form pursuant the Italian Civil Code of Procedure. If the value is undetermined or indeterminable or there is a relevant difference between the parties with regard to the assessment, the Provider will fix a reference value (up to 25.000,00). Where a different economic value emerges during the mediation process, fees will be due accordingly.

### **B – Registration fees**

Registration fees consist in a fixed charge (col. B) which is provided by the Legislative Decree n. 28/2010 and 10 Euro + VAT to cover out-of-pocket expenses. Registration fees are to be paid by the filing party at the time of the filing and by the invited party at the time of the filing of the mediation reply form.

### **C – Mediation fees**

Mediation fees depend on the economic value of the dispute and cover the Provider's fees and the mediator's fees regardless of the number of meetings or the number of mediators.

#### **a) FIRST MEETING WITH THE MEDIATOR.**

Mediation fees shall be paid by the parties when an agreement is reached during the first meeting with the mediator. If the parties do not reach any agreement and decide to quit the mediation proceedings at the end of the first meeting, no mediation fees will be due.

#### **b) CONTINUATION OF THE PROCEEDINGS.**

If the parties decide to proceed with the mediation after the first meeting, the Provider will ask for the balance of the mediation fees to be paid before the next meeting.

However, the parties can be charged with smaller fees if it is considered appropriate by the Provider, and the balance can be asked at the end of the proceedings if an agreement is reached.

### **D – Success fees**

A success fees is due when an agreement is reached except when the case is settled during the first meeting with the mediator.
