Innovative Change at the Milan Chamber of Arbitration

THE NEW ARBITRAL COUNCIL, THE TECHNICAL BODY THAT OVERSEES ALL STAGES OF ARBITRATION, IS BORN

It appoints arbitrators, supervises their activities and the duration of proceedings, ensuring that disputes are resolved expeditiously

Internationally renowned experts join the team

Milan, March 2021. News in arbitration: the members of the new Arbitration Council of the Milan Chamber of Arbitration (CAM) were appointed. They are law professors, lawyers and ADR experts at national and international level. They join the CAM team to perform high-profile functions aimed at ensuring the application of the Arbitration Rules. Specifically, the Arbitral Council appoints and confirms arbitrators according to the provisions of the Rules, settles the fees and costs of the proceedings, supervises the duration of the arbitral proceedings, with the support of the General Secretariat, and monitors the activities of arbitrators and parties to ensure an expeditious resolution of disputes. The new Board takes office on March 26, with a two-year term.

The Arbitral Council. Its powers. The Arbitral Council is a technical body of the Milan Chamber of Arbitration. It has general jurisdiction over all matters relating to the administration of arbitration proceedings and can adopt all necessary measures as provided for by the Rules, except for the powers attributed by the Rules to the General Secretariat.

Jurisprudence of the Arbitral Council. The decisions of the Arbitral Council are periodically published on the website of the Milan Chamber of Arbitration ([link](#) for consultation). The publication consists of an anonymous collection of cases in which the Arbitral Council is called upon, to assess the confirmation or the non-confirmation of the arbitrator, on the basis of the declaration of independence and on the observations or challenges submitted by the parties. The published cases constitute a first institutional jurisprudence on arbitration matters and contribute to a better dissemination of the culture of independence and third-party status of the arbitrator.

The new Arbitral Council. The news. The new president is è Enrico Giliberti.
