MEDIATION FEES CHART

Effective for mediation applications filed from 15 November 2023 onwards

All sums are to be paid by each party in accordance with the terms and manner specified by the Secretariat.

Where several parties claim to represent a single centre of interests, they will be considered a single party.

The fees in the Mandatory Mediation table shall apply when:

- the dispute concern condominium, rights in rem, division, hereditary succession, family pacts, leases, commodatum, business leases, compensation for damages arising from medical and healthcare liability and from defamation in the press or other advertising media, insurance, banking and financial contracts, partnership, consortium, franchising, work contract, network, administration, partnerships and subcontracting;
- the judge orders a mediation attempt;
- the dispute concerns the energy sector

In all other cases Voluntary Mediation fees apply.

The requesting party shall pay the allowances for the first meeting at the time the request is filed, and the invited party shall pay at the time it joins the mediation.

The amount payable as first meeting is determined by adding together the amounts referred to in Article 28, paragraph 4 (initiation expenses) and paragraph 5 (mediation expenses for the first meeting), of Decree No. 150/2023.

To ensure correct notification by registered mail, please carefully check the data entered in the application, preferably using an up-to-date certificate of residence or Chamber of Commerce certificate.

If the invitation is not delivered due to an incorrect address, it will be the applicant's responsibility to renew the invitation to mediation at their own expense with the support of the Mediation Body, who will provide the relevant documentation.

Additional mediation fees are payable in the following cases:

- if the parties decide to continue the mediation process beyond the initial meeting. The amount charged includes the “success fee”, which will be refunded if the proceedings end without an agreement being reached.
- if the parties reach an agreement, even at the first meeting.

TARIFF SCHEDULE FOR FIRST MEETING FEES AND ADDITIONAL MEDIATION COSTS

(AMOUNTS WITHOUT VAT)

According to Article 1 of Presidential Decree No. 633/72, VAT is due on all supplies of goods and services carried out within the State's territory for commercial or professional purposes, as well as on imports.

VAT is due if the party involved in the mediation has its registered office in Italy.

However, if the party has its registered office abroad in an EU member state and is registered in the VIIES (the EU database of economic operators qualified for intra-Community transactions), VAT is not due.

If the party has its registered office abroad in a non-EU state, VAT is due.

TAX FACILITIES

Pursuant to Legislative Decree 28/2010 and Ministerial Decree 150/2023, the parties are entitled to the following tax benefits: - exemption from registration tax on conciliation agreement minutes up to a value of €100,000. For higher values, tax is only due on the excess amount; - a tax credit of up to €600 for mediation and legal fees for each mediation procedure, up to an annual total of €2,400 per individual and €24,000 per legal entity. This tax credit is halved if mediation fails; - a tax credit of up to €518, in proportion to the unified contribution paid by the party in cases that are terminated following the conclusion of the conciliation agreement. There are no tax reliefs for conciliations on energy matters.

LEGAL AID

The party unable to afford legal representation is granted legal aid by the relevant Bar Council does not have to pay for legal representation if an agreement is reached during mediation on matters covered by the condition of procedural legality and it does not bear the costs of mediation, regardless of the outcome of the mediation.

BILLING

The invoice for mediation expenses shall be addressed to the parties directly involved in the mediation procedure (as set out in Resolution No. 331350 of 13 June 1981 – Min. Finanze – Taxes and Indirect Taxes on Business). It is not possible to invoice the law firm or any other parties not directly involved in the mediation.

For internal organisational reasons, courtesy copies of invoices cannot be issued, nor can specific wording be inserted to customise the description of the service subject to the transaction.
