## FEE CHART (annex A)

Effective for claims filed from 4 April 2022.
The costs (indemnities) include the costs of initiating the proceedings and the mediation expenses.
All sums indicated include VAT and are payable by each party. When several parties claim to represent a single centre of interests, they are considered to be a single party.

## A - Value of the dispute

The value of the dispute is indicated in the application in accordance with the Italian Code of Civil Procedure. If the value of the dispute is undetermined, indeterminable, or there is a considerable divergence between the parties on the estimate, the Organisation decides on the reference value up to the limit of $€ 250,000.00$ and communicates it to the parties. If, at the end of the mediation proceedings, the value turns out to be different, the amount of the indemnity is due according to the corresponding reference bracket.

B - Registration fee
The registration fees shall consist of the fixed sum indicated in the Table (col. B) and shall include the amount set out in LD 28/2010 and the amount of euro 10 + VAT set out to cover out-of-pocket expenses.

The registration fee shall be paid:

- by the requesting party after filing the application, on the instructions of and within the time limits indicated by the Secretariat;
- by the invited party after joining the proceedings, upon indication and within the deadline indicated by the Secretariat.

Registration fee are due for the conduct of the first mediation meeting, even if the mediation attempt is not continued.
C - Mediation Expenses
Mediation expenses depend on the value of the dispute and include both the service's fee and the mediator's fee, regardless of the number of mediators and meetings.

Mediation fees are regulated as follows:
A. FIRST MEETING.

Mediation fees are due when the parties, at the first meeting, reach an agreement. Mediation fees are not due when the parties, at the first meeting, reach no agreement and abandon the mediation.

## B. CONTINUATION BEYOND THE FIRST MEETING.

In the event that the parties, at the first meeting, decide to continue the mediation with subsequent meetings, the Service requires the parties to pay the full mediation expenses before the second meeting.

However, the Service may, if it deems it appropriate, request lower amounts from the parties than the mediation expenses. In this case, the balance of the mediation expenses will be requested when the parties reach an agreement at the second or subsequent meetings.

D - Success fee in case of agreement
The success fee is due in all cases where agreement is reached between the parties, unless agreement is reached at the first meeting.
